### **Guidelines for visiting the EPO1 Center for Contemporary Art**

These visitor guidelines apply to the entire premises of the EPO1 z. s. association (hereinafter referred to as "EPO1" or "gallery") with its registered office at Elektrárenská 322, 541 03 Trutnov–Poříčí. They are binding for all visitors to events held on the premises, including adjacent outdoor areas, as well as other locations where EPO1 carries out its program activities. This also applies to visitors to events held in the Chapel of St. Joseph in Slavětín and other external locations. Compliance with the Visitor Guidelines is mandatory for all such events.

# 1. General provisions

- By entering the exhibition and other publicly accessible areas, visitors express their agreement with these visitor guidelines and undertake to comply with them.
- Children under 12 years of age are only allowed access when accompanied by a person over 18 years of age who is responsible for them at all times.
- Visitors are required to behave in such a way as not to endanger their own safety or that of others, not to damage exhibits, equipment, or premises, and to maintain the dignified atmosphere of a cultural institution.

### 2. Admission and accessibility

- Admission is only permitted with a valid ticket, accreditation, or other authorization issued by the gallery or organizer.
- The number of visitors in some areas may be limited for safety reasons.
- Any discounts, free admission, and specific conditions are determined by the current price list or management decision.

## 3. Security and protection of collections

- Visitors acknowledge that their movements may be monitored by a camera system installed for the purpose of protecting persons, property, and exhibited works. Recordings are stored for a period of 30 days.
- It is forbidden to touch exhibits, frames, pedestals, and display cases, unless expressly stated otherwise.

### 4. Rules of operation

- Smoking, including electronic cigarettes, bringing in alcohol, narcotics, weapons, and other dangerous items is prohibited.
- Animals are not allowed, with the exception of assistance dogs.
- Basic hygiene rules must be observed on the premises and waste sorting rules must be respected.

### 5. Photography and recordings

- Photography for personal use is permitted unless otherwise stated. The use of tripods, flashes, or professional equipment is only permitted with the consent of management.
- Commercial or publication recordings require prior approval.

# 6. Parking

 Parking is available in designated areas. Parking is not permitted in areas marked as fire zones or other restricted areas.

### 7. Emergency situations

- In the event of an emergency, visitors are required to follow the instructions of authorized personnel, firefighters, or police officers.
- Any accident or other incident must be reported to staff immediately.

### 8. Responsibility

• The gallery is not responsible for lost or damaged items if they were not stored properly. Visitors are responsible for any damage caused by their behavior.

## 9. Scope of validity

• These visitor guidelines apply to the entire EPO1 complex in Trutnov, adjacent areas, and events held outside the main complex—for example, in the Chapel of St. Joseph in Slavětín or other venues where EPO1 organizes exhibitions, cultural events, or educational programs.

- The EPO1 Association reserves the right to update these visitor guidelines at any time.
